

The Privacy Policy (hereinafter referred to as the "POLICY") is an integral part of the Public Agreement (hereinafter referred to as the Offer, the Agreement), which is the official offer of the "Administrator" on the site for the organization of the placement and coverage of texts, graphic images, projects, achievements (hereinafter - "Content"), describing the experience and competence of "Users" who wish to use this platform to promote their services / works.

The terms and concepts used in this Policy are similar to the terms and concepts used in the main text of the Offer.

WE STRONGLY RECOMMEND THAT YOU FAMILIARIZE YOURSELF WITH THE PRIVACY POLICY

By using the Site, as well as the Services and Services provided by the Administrator on the Site, the User agrees to this Policy. The User does not have the right to use the Site if he does not agree with the terms of this Policy, or if he has not reached the legal age, when he has the right to enter into agreements with the Site Administrator, or is not an authorized person of the Administrator.

Confidential is information about an individual, as well as information, access to which is limited to an individual or legal entity, with the exception of public authorities. Confidential information may be distributed upon request (consent) of the person responsible in accordance with the terms and conditions stipulated by it, as well as in other cases determined by law (Article 21 of the Law of Ukraine of 02.10.1992 No. 2657-XII "On Information").

In this Policy, confidential information means all identification information received by the Administrator from the Visitor and/or the User during his stay on the Site and/or registration on the Site and the creation of the Account, as well as when using the Website Services provided by the Administrator. This information, if necessary, can be used to communicate with the User and / or the Visitor, both online and in other ways. Personal data is an integral part of confidential information provided by the User and/or the Visitor solely on a voluntary basis and with his consent.

The User understands and recognizes that in case of negligence in the security and protection of his personal data and data of the User's Account, third parties may gain unauthorized access to the Account and personal other data of the User. The administrator is not liable for damages caused by such access.

Also, the Administrator is not responsible for obtaining, storing, processing, using and disclosing the User's personal data to third parties who are not trustees of the Administrator.

LIST OF DATA COLLECTED BY ADMINISTRATOR

1. Personal information: name, surname, patronymic, date of birth, contact phone numbers, e-mail address, Facebook user name, payment details, other information

provided by the User when registering on the Site and creating his Account, as well as content downloaded by the User;

2. Cookies for determining the user's browser; User behavior in the site and activity log

3. Information from other sources. The Administrator may receive information from other persons who are Visitors and / or Users of the Site. Also, the Administrator may receive information about the User if the latter uses any other website used by the Administrator, or other Services or Services provided by the Administrator. The administrator may have subcontractors in the field of technical or financial services, analysts and/or data search specialists, etc., who can receive information from the User.

HOW TO SAVE ADMINISTRATOR DATA

The administrator collects, stores and uses confidential information in strict accordance with this Policy. The Administrator takes all necessary measures to ensure the proper storage and use of the received information. The collection of confidential information occurs automatically when visiting the Site and using the Administrator Services, as well as when the User and / or Visitor fill out the proposed forms during registration.

The Administrator can use the name, surname, patronymic, date of birth, e-mail address, Facebook user name, password to identify the User on the Administrator's Website.

The Administrator can use the User's contact information in the mailing lists, namely, but not exclusively, to report new features, promotions and other news of the Site. The User can always unsubscribe from the newsletter to his/her contact information in the relevant section of his Account.

Information about the User, including personal data, is used to ensure the implementation of civil, tax and accounting relations, as well as to fulfill contractual obligations for the provision of services. Additionally, personal data will be used to identify the Site User, for the purpose of providing and offerings, services, processing payments, creating and implementing bonus programs, sending commercial offers and information by mail, e-mail, providing new services, transmitting any information, except for the subject matter of the Agreement, conducting settlement transactions, reporting, accounting and management accounting, improving the quality of services, providing the Website Services, posting information about the User on the Site, creating and maintaining the User's Account, processing and posting user Content.

The administrator does everything possible to minimize the risk of unauthorized access to confidential information, as well as the risk of its misuse, but does not bear any responsibility in case of access to confidential information by third parties. In case of disputes when using the Website and the Services of the Administrator, as well as in other cases stipulated by the Offer or the current legislation of Ukraine, the User and / or the Visitor undertakes to provide the Administrator with all his/her personal data at his request. The Administrator reserves the right to store information as long as the User's account is active or the information is necessary to provide services to

the User. The Administrator will store and use the User's confidential information if it is necessary to fulfill legal obligations to the User and/or resolve disputes.

ADMINISTRATOR'S USE OF DATA

The Administrator may use the personal data that the User has provided personally for the following purposes:

- fulfillment by the Administrator in accordance with the terms of the Offer of its obligations to the User;
- providing the Administrator with information to the User about the services offered by the Administrator, similar to those that have already been purchased by the User or are still of interest;
- providing the Administrator with information about services that, according to the Administrator, may be interesting or useful for the User;
- notification of the User about changes on the Website of the Administrator or other Services;
- placement by the Site content administrator in the most effective way to improve usability.

The Administrator may use the User's personal data obtained from other sources for the following purposes:

- fulfillment by the Administrator in accordance with the terms of the Offer of its obligations to the User;
- administration of the Site, as well as for internal operations, including damage search and elimination, data analysis, testing, implementation of statistical and research purposes;
- improving the work of the Site, in particular, in order to make sure that the content of the Site is displayed in the most effective and convenient way for the User;
- creation of conditions under which the User will be able to participate in interactive functions of the Administrator's Website;
- improving and ensuring the security of the Site;
- evaluation of the effectiveness of advertising;
- provision of new services that may be of interest to the User.

The Administrator may combine the information provided by the User with information taken from other sources for the purposes set forth above.

COOKIE

Cookies are pieces of information that any website transmits to the user's hard drive to store information related to this site. This technology increases the Ability of the User to use the Internet while maintaining priorities when viewing a particular site. The cookie technology does not contain personal information and in no way can configure the User's system or read information from the User's hard drive. The user can control the use of cookies at the level of a separate browser. If the User refuses cookies, he can use the Site of the Administration at the same level, but the possibility of using some functions or areas of the Site may be limited.

The administrator can use pixel tags that allow sending e-mails in the format available to the User, as well as allow you to determine whether the corresponding message has been opened and read. Your administrator can use this information to reduce or discard messages.

ADMINISTRATOR DISCLOSURE

The Administrator undertakes not to transfer confidential information, personal data or content to the User to third parties, except as expressly described in these Rules, or in connection with the use of the Site. The Administrator may share the User's information with third parties, in particular:

- partners, suppliers, contractors/subcontractors to fulfill any contract that the Administrator will conclude with the User;
- contractors and search engine specialists who help the Administrator in improving and optimizing the Site.

In some cases, the Administrator may disclose the User's personal data in response to legitimate requests from the state, including law enforcement agencies. The Administrator may disclose the User's personal data to third parties:

- in the event that the Administrator sells or buys any business or assets - in this case, the Administrator has the right to disclose the User's personal data to a potential seller or buyer of such business or assets;
- if the Site or almost all of its assets are purchased by a third party - in this case, the User's personal data will be transferred as an asset.
- if the Administrator is obliged to disclose or transfer the User's personal data in order to fulfill any legal obligations or to ensure compliance or application of the license agreement; or to protect the rights, property or safety of the Administration or other Users. This includes sharing information with administrators of other sites or organizations in order to protect against fraud and reduce any financial risk.

If the Administrator participates in the merger, acquisition or sale of all or part of his assets, the User will be notified of this by e-mail or by posting a corresponding notice on the Site.

USERS' ACCESS TO PERSONAL DATA

The Administrator will make reasonable efforts to provide the User with access to any personal information within 20 days from the date of receipt of the relevant request. If the User's personal information has been changed or the User no longer intends to use the Website of the Administration, the User may independently correct, update, modify, delete, demand the deletion of personal information, including personal Content, from public forums, cataloguing, disable (delete) his Account or ask the Administrator to do so by sending an email to the Administrator's email address.

ADDITIONAL TERMS IN THE PRIVACY POLICY AND IN ACCORDANCE WITH GDPR TERMS

The administrator has the right to unilaterally make changes to the Privacy Policy in the future. The changes will be published on the Site before they take effect. The Administrator can notify about the relevant changes by sending an e-mail to the User.

By using the Site and/or The Site Services, ordering services, participating in promotions, research or otherwise interacting with the Site Administrator, the User agrees to all the terms of the Privacy Policy in the current version. The user is advised to check this Policy for updates or changes to the Privacy Policy.

If any part of this Privacy Policy is invalid or unworkable, other parts of this Privacy Policy will remain in force.

The User is endowed with the rights stipulated by the Law of Ukraine "On Personal Data Protection" of June 1, 2010 No. 2297-VI.

The processing of personal data by the Administrator is lawful and fair.

By using the Site, the User/Visitor confirms that his/her personal data is collected, used, viewed or otherwise processed, as well as the extent to which personal data are processed or processed.

All messages regarding the processing of personal data specified in this Policy are easily accessible, understandable and presented in simple language.

The Administrator notified Users/Visitors about who is the data controller, about the purposes of data processing, as well as additional information to ensure fair and transparent processing of relevant individuals and their right to receive confirmation of information related to them and personal data that are processed.

The User/Visitor is notified of risks, rules, remedies and rights regarding the processing of personal data and how to exercise their rights in connection with such processing.

The Administrator guarantees that the use of personal data is limited by the time of use of the Site by the User/ Visitor and after deleting the User/Visitor's Account from the Site, such Personal Data of the User is deleted as well.

With this section, the Administrator confirms that this Privacy Policy fully complies with the gdpr regulations and principles (GeneralData Protection Regulation).
